SECTION 151. Demits For Continuous Membership. If a brother wishes to change his membership and be continuously affiliated, he may file his petition with the lodge with which he wishes to affiliate, and with it his current dues receipt or statement from his Secretary, under the seal of the lodge showing that his dues are paid to the date the request is received by his lodge; also, a written application to his lodge for a demit. If elected to membership in the lodge petitioned, the Secretary thereof shall immediately forward said application for demit to the brother's lodge and when the demit is received shall file it with the petition and enter the brother's name as a member of the lodge petitioned as of the date the demit is granted. If the petitioner be rejected, the aforesaid receipt for the dues and application for demit shall be returned to him.
